



## Issue of Shares Appendix 2A & Cleansing Notice

Carnavale Resources Limited (Carnavale or the Company) advises the issue of 10 million ordinary shares (Shares) to Western Resources Pty Ltd (a non-related party to Carnavale or its Directors) as partial consideration for the right to acquire 80% of the Ora Banda South Project, which covers an area of approximately 25km<sup>2</sup> located 65km northwest of Kalgoorlie in the Yilgarn Craton, Western Australia.

The Shares were issued under the Company's existing placement capacity under Listing Rule 7.1.

The Company also advises the issue of 66 million Shares to Mr Klaus Eckhof arising from the conversion of 66 million performance rights. 33 million performance rights vested upon the completion of the Company's Shares having traded at a volume weighted average price of at least \$0.009 for a consecutive period of at least 15 business days and 33 million performance rights vested upon the completion of the Company's Shares having traded at a volume weighted average price of at least \$0.011 for a consecutive period of at least 15 business days. The performance rights were approved by shareholders at the 2019 Annual General Meeting.

Mr Eckhof is responsible for marketing the Company and its projects throughout North America and Europe.
