Exploration Licence E38/2055 is located approximately 7kms south of the Granny Smith Mine and approximately 25km south of Laverton in the Mt Margaret Mineralfield. The Licence covers the area adjacent and south of the Acacia resources area of Windich South which lies between the Granny Smith Mine and the licence.

No exploration was carried out on the project during the quarter.

Corporate

During the previous quarter, the Company submitted licence applications for areas considered to be highly prospective for gold in Central Africa. These licence areas were selected on the basis of geological interpretations and a mineralisation targeting exercise.

Additional follow up information for the application process is continuing.

The Company can give no assurance that these applications will be granted.

The Company will continue to seek new natural resources investment opportunities in order to increase the size and diversity of the Company's portfolio.
