ISSUE OF SECURITIES

Further to its previous announcements, Carnavale Resources Limited (ASX: CAV) advises the completion of the issue of 15,315,908 shares together with 30,631,816 options exercisable at 3 cents expiring on 30 November 2016, being the shortfall from the recently completed fully underwritten non-renounceable entitlement offer.

In addition, the Company has also completed the issue of 3,000,000 shares for underwriting services. An Appendix 3B is attached with respect to the issue of these securities and Carnavale Resources Limited gives notice that:
